# CITY OF BELLEVUE, WASHINGTON

## ORDINANCE NO. 6476

AN ORDINANCE approving the rezone application Permit File No. 19-106704-LQ (Sambica Activity Center); rezone of a 7.62-acre site at 4114 W Lake Sammamish Parkway SE from Neighborhood Business District (NB), Multi-Family Residential (R-20), and Single-Family Residential (R-5) to Camp and Conference Center (CCC).

WHEREAS, an application was submitted on February 25, 2019 for a rezone from Neighborhood Business District (NB), Multi-Family Residential (R-20), and Single-Family Residential (R-5) to Camp and Conference Center (CCC) located at 4114 W Lake Sammamish Parkway SE, the legal description of which is attached hereto as Exhibit A and by this reference fully incorporated herein; and

WHEREAS, public notice of the request was published on March 28, 2019 and the request was considered at a public meeting on April 8, 2019; and

WHEREAS, a public hearing was held before the Hearing Examiner for the City of Bellevue on June 20, 2019 pursuant to notice required by law; and

WHEREAS, on June 27, 2019, the Hearing Examiner recommended approval of the rezone application, and made and entered findings of fact and conclusions of law based thereon in support of that recommendation, and no timely appeal thereof has been filed; and

WHEREAS, the City Council concurs in the findings of fact and conclusions of the Hearing Examiner, and has determined that the public use and interest will be served by approving the rezone; and

WHEREAS, the City has complied with the requirements of the State Environmental Policy Act and the City Environmental Procedures Code and adopted the Determination of Non-Significance previously issued for the Comprehensive Plan Amendment on October 30, 2008 regarding the site; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The City Council adopts the findings of fact and conclusions based thereon, made and entered by the Hearing Examiner in support of the recommendation to the City Council with regard to the hereinafter described property as set forth in Findings, Conclusions and Recommendations of the Hearing Examiner for the City of Bellevue "In the matter of the Application for rezone of a 7.62-acre site at 4114 W Lake Sammamish Parkway SE from Neighborhood Business District (NB), Multi-Family Residential (R-20), and Single-Family Residential (R-5) to Camp and Conference Center (CCC). Permit File No. 19-106704-LQ."

Section 2. The property legally described in Exhibit A, which is attached hereto and by this reference fully incorporated herein is hereby reclassified from NB, R-20, and R-5 to CCC.

Section 3. This ordinance shall take effect and be in force five (5) days after passage and legal publication.
