 - public information and education materials on panhandling
- Perform due diligence and open discussions with Sound Transit to determine a path forward for a homeless shelter, which could include affordable housing and a day center, in conjunction with the OMF East site

- Comprehensive approach
- Clear, specific, enforceable
- Evaluate:
 - Existing protocol
 - Existing enforcement tools
 - Identify gaps
 - Current resources
- Options for code modifications

Vehicle parking/camping

Example items under review:

- 24-hour parking limits
- Trash dumping and/or accumulation
- Waste tank dumping
- RV generators
- Identify any resource needs

Outdoor camping

Evaluation of:

- Gaps/improvements in existing protocol
- Public property versus public easement
- Identify any resource needs

Panhandling

- Undertake public education campaign
- Develop messaging
- Near-term (immediate)
 - Continued partner collaboration
 - BellevueNOW
- Long-term (through summer)
 - Webpage content
 - Community resource guide

OMF East Site

- Opened discussions
- Continued coordination
 - Identify next steps for both agencies
