

# King County Snapshot

2016: 219 deaths from opioids and heroin

Significant increase in the number of people entering treatment programs

Teens ages 14-15 represent the peak time of initiation into opioid misuse

# King County Heroin and Prescription Opiate Addiction Task Force

Convened in 2016

Charged with developing strategies for prevention and improving access to treatment

50 representatives from various King County organizations, including hospitals, police and fire agencies, human service and other health care providers

# King County Heroin and Prescription Opiate Addiction Task Force

- Task Force developed 8 recommendations for:
  - Primary Prevention
  - Treatment Expansion
  - User Health and Overdose Prevention

1. Raise Awareness and Knowledge

#### King County

- Awareness and education forums
- Mental Illness and Drug Dependency (MIDD sales tax) funding for prevention education – physicians, pharmacists, health care providers, and the public
- Bellevue/Eastside
  - Eastside Human Services Forum
  - Bellevue Human Services Commission
  - ► King County Public Libraries Bellevue

### 2. Promote Safe Storage and Disposal

#### King County

- 100 drop-box locations
- Mail-back envelopes
- Bellevue/Eastside
  - Secure drop-box in Police Lobby of City Hall
  - 7 pharmacy take-back locations



- 3. Prevention & Early Identification
- King County
  - Screening, Brief Intervention and Referral to Treatment (SBIRT)
  - Screening tool for early identification of drug and alcohol problems
  - The Best Start for Kids (BSK) Levy funding SBIRT in middle schools
- Bellevue/Eastside
  - Bellevue School District developing SBIRT plan for middle schools
  - BSK is funding health clinic at Highland Middle School
  - Eastside Pathways Mental Health and Wellbeing Collaborative

#### 4. Create Access to Buprenorphine (Suboxone)

#### King County

- 100 public and private health care providers that have received training and can prescribe buprenorphine
- \$500,000 in MIDD funding will be used to expand access
- Bellevue/Eastside
  - 16 public and private health care providers in Bellevue can prescribe buprenorphine

#### 5. Develop Treatment on Demand For All Types of Services

#### Bellevue funds the following programs:

Youth Eastside Services	Mental health counseling and substance abuse treatment to children and youth ages 6-22	\$168,747
Therapeutic Health Services	Outpatient drug & alcohol treatment Medication Assisted Therapy (methadone)	\$105,509
Sound Mental Health	School and community based services for children, youth and adults with mental health and substance abuse issues	\$ 38,500
Friends of Youth	Provides substance abuse treatment services to youth, young adults and their families	\$ 88,960
HealthPoint	Provides medication assisted therapy	\$ 60,272

6. Alleviate Barriers Placed on Opioid Treatment Programs

- King County
  - International Community Health Services (ICHS) affordable health care services for underserved populations
- Bellevue/Eastside
  - HealthPoint affordable health care services for low-income populations
  - Therapeutic Health Services outpatient drug and alcohol treatment, including medication-assisted treatment

- 7. Expand Distribution of Naloxone (Narcan) in King County
  - King County
    - State legislation authorized pharmacies to supply a nasal form of Narcan without a prescription
    - On Medic Units for many years; now carried by all fire response units
    - MIDD funding is being used to expand distribution of Narcan
  - Bellevue/Eastside
    - Narcan carried on Medic Units for many years; now carried by all fire response units
    - Police Department narcotics officers are trained and carry Narcan nasal spray

- 8. Establish Pilot Program for Two Safe Injection Sites
  - This recommendation has received the most scrutiny and publicity
  - Several cities have banned the sites, including Federal Way and Auburn
  - Tonight's briefing is not intended to address this recommendation

# Next Steps

Bellevue's 2017-2018 Human Services Needs Update

Continue to provide services that address prevention and treatment

Urge King County elected officials to evaluate programs/services funded by levies and other taxes to ensure effectiveness, avoid duplication and reduce administrative overhead
