2016 Comprehensive Plan Amendments Overview

- According to the Growth Management Act, jurisdictions may amend their comprehensive plans once per year
- Vision Zero is Bellevue's Comprehensive Plan Amendment for 2016
 - Council initiated this CPA
 - Planning Commission recommendation to Council
 - Council is requested to provide direction to bring policies for adoption on December 12

Vision Zero Bellevue Resolution No. 9035

Bellevue City Council unanimous approval - December 7, 2015

WHEREAS, the worldwide Vision Zero movement is founded on the belief that death and injury on city streets is unacceptable and preventable

• The City of **Bellevue endorses Vision Zero** as part of a comprehensive effort to strive to achieve zero traffic deaths and serious injuries on Bellevue streets by 2030.

Vision Zero Bellevue Transportation Commission Policy Recommendation


Council Asked: Are any "updates, revisions, or additional policies" needed in the Transportation Element to incorporate Vision Zero?

Transportation Commission Responded: Yes, amendments to the Transportation Element are needed to comprehensively incorporate Vision Zero as a framework for traffic safety




Traffic fatalities and serious injuries People walking, City of Bellevue, 2006-2015

Traffic fatalities and serious injuries People driving, City of Bellevue, 2006-2015



Crash map portal is an interactive tool that enables the user to view collisions, by mode, citywide.




Transportation Commission Policy Recommendation to Council

March 7, 2016

Transportation Commission transmitted a Vision Zero policy recommendation to the City Council

- Council initiated
 Comprehensive Plan

 Amendment
- Planning Commission began review and recommendation



Planning Commission Policy Recommendation

After reviewing the Transportation Commission recommendation, holding a public hearing, and deliberating on November 9, 2016, the Planning Commission now transmits to the City Council our recommendation for Vision Zero policies to be incorporated as an amendment to the Comprehensive Plan

If adopted in the Comprehensive Plan, Vision Zero policies will support and expand ongoing work in Bellevue toward Zero traffic-related deaths and serious injuries by 2030

Vision Zero Bellevue: Policy Recommendation

Four New Policies

- ► TR-61.1. Strive to achieve zero traffic deaths and serious injuries on Bellevue streets by 2030.
- ► TR-61.2. Develop a programmatic approach to Vision Zero that integrates components of Education; Encouragement, Enforcement; Engineering; Equity; and Evaluation.
- ► TR-61.1. Design and manage streets to foster safe and context-appropriate behavior of all roadway users.
- ► TR-116.1. Strive to provide separation between motorized vehicles, pedestrians and bicyclists, as feasible, reasonable and appropriate to the context, while maintaining adopted level-of-service standards for all modes.

Vision Zero Bellevue: Policy Recommendation

Amendment to One Existing Policy

► TR-55. Maintain a collision reduction program to identify high collision locations, evaluate <u>and prioritize</u> potential safety improvements and implement recommended changes.

Policy Implementation Vision Zero Programmatic Approach

A Programmatic Approach supported by Bellevue policy

- Prepare and implement a Vision Zero Action Plan that incorporates the 6 Es and includes a clear purpose, outcomes, community involvement, action items and performance measures
- Update Vision Zero strategies periodically
- Provide Vision Zero status reports that aggregate and analyze data, document efforts, and communicate progress to the City Council and to the community

What Vision Zero Policies will Mean: A Programmatic Approach to Traffic Safety with the 6 Es

Education: Inform residents about traffic laws and safe behavior.

Encouragement: Incentivize safe behavior. Instill respect for one another on the city streets.

Enforcement: Focus efforts at highest crash locations. Protect vulnerable people.







What Vision Zero Policies will Mean: A Programmatic Approach to Traffic Safety with the 6 Es

Engineering: Design streets for all travel modes to be safe for everyone.

Equity: Ensure that safety applies to everyone; no matter who you are, what mode you are using, or where in the city you are traveling.

Evaluation: Monitor progress, adjust strategies, and celebrate success.
