May and June – Sustained review of the long range financial capital plan. Narrowed to three areas with a public engagement plan:

- Mobility in BelRed (through TIFIA Loan)
- Fire Long Range Facilities
- Transportation Neighborhood Safety and Connectivity

CIP, TIFIA, and Potential Ballot Measure(s)

Existing CIP:

Resource constrained – builds infrastructure. Trans., Parks, Gen Gov, Debt Service, etc...

In 2014, updated in 2016 – long range financial plan shows:

\$1.2 Billion of potential projects and \$400M in revenue.


Gap of \$800M over 20 years.

TIFIA Loan – BelRed Mobility (up to \$100M)


Potential Ballot Measure(s) – Fire/TNSC - at surveyed rate of 12.5 cents/\$1000 AV each = ~\$5.5M yr; ~\$38M over 7 yrs; ~\$120M in 20 yrs.








Neighborhood Traffic Safety Candidate Projects: Resident-Requested Study Areas








Things in Bellevue headed generally in the Right Direction/Wrong Direction




