#### EE EIS - Council Role

- State Environmental Policy Act requires environmental review on "actions"
- Action with respect to this PSE project is anticipated issuance of a permit
- Responsibility for the City's environmental review process delegated to the City's SEPA Responsible Official
- Process proceeds under codes and regulations
- City of Bellevue is lead agency with a number of other jurisdictions through which the project is expected to run
- Council participating in this process as a stakeholder, not a decision-maker

#### Phase 2 EE DEIS – Alternative 2 Integrated Resource

- Phase I concluded that Alt. 2 components would be unlikely to be able to meet project objectives of capacity, cost, reliability and electrical and non-electrical criteria
- In addressing project need the alternative would result in uncertainty about how much infrastructure would be installed and how much additional supply would be needed and able to be provided each year.
- Not a reasonable alternative under SEPA definition to define the range of possible alternatives to meet PSE's objectives.
- Complete analysis of this will be included in Final EIS

- May 9 and May 16 for Council comment review
- Early 2017 DEIS issued
- Spring or summer 2017 FEIS issued
