Dear Gardeners:

It looks like we have some nice weather coming our way this weekend! As garden cleanup is underway, we wanted to remind everyone that the dumpster has arrived and will be here until October 31st. It is available for both Year-round and Seasonal plot cleanup. Please use it for any garden refuse including wire, wood, plastic, green waste, etc.

This fall we will be adding a post and rail fence to the garden perimeter in effort of reducing garden theft. The fence will have openings for existing pathways allowing pedestrian and wheelbarrow access to the garden. In addition to the fence we are reevaluating our Don't Pick the Produce signs and their placement.

As garden cleanup wraps up this season, we wanted to remind everyone of the following:

 We have a cooler at the Ranger Station (located on the porch) for anyone who has any produce donations for Hopelink. It is dropped off every Monday.

- Please remember that items cannot be stored in the general community garden areas. This is considered dumping and is not allowed in the garden. Dumping has become a growing issue the past couple of seasons. To address this problem, items which are found in the surrounding site from individual plots will result in the loss of plot renewal or a future garden plot.
- Garden renewal packets will be mailed out in November this year with a hard deadline of January 31, 2020. We need to have the renewal packet including payment by this date or your plot will be reallocated. Please contact us to update your mailing address if you did not receive your garden closure letter in the mail this fall.
- Please feel free to reach out to us with any questions or concerns.

Description: Development of this Temporary Encampment Land Use Code Amendment (LUCA) is authorized to update Land Use Code Chapter 20.30U, which covers permitting of temporary encampments hosted by religious organizations on their property and is following the adoption process for a development regulation under the State Growth Management Act (GMA) integrated with review required under the State Environmental Policy Act (SEPA). The staff report analyzing the LUCA against decision criteria for amendment to the text of the Land Use Code and summarizing the environmental effects of the proposal is attached. This LUCA is intended to eliminate the need to refer to both Chapter 20.30U LUC and the provisions of an existing Consent Decree when administering temporary encampments in the City.
