EXECUTIVE SUMMARY

This Ordinance adopts the Human Services Commission's 2020 CDBG funding recommendations as presented to the Council at the October 28 Study Session.

RECOMMENDATION

Move to adopt Ordinance No. 6484

BACKGROUND/ANALYSIS

The annual amount of CDBG funding received by the City is based on a formula calculated by HUD. Bellevue's exact CDBG entitlement amount for 2020 will not be known until after the 2020 federal budget has been adopted. The annual CDBG budget also includes loan paybacks, known as program income, from the Major Home Repair program. The estimated CDBG budget for 2020 is as follows:

2020 Estimated CDBG Entitlement: \$764,000
2020 Estimated Program Income: \$153,000

Total Estimated 2020 Funds: \$917,000

The Human Services Commission's 2020 CDBG funding recommendations (Attachment A) were presented to the Council at the October 28 Study Session. The Contingency Plan (Attachment B) outlines how the funding will be allocated if the actual CDBG budget is higher or lower than the estimated amount.

POLICY & FISCAL IMPACTS

Policy Impact

Comprehensive Plan, Human Services Element

- HS-3. Identify opportunities and develop strategies that are preventive in their approach to human services' needs.
- HS-4. Allocate funds and other resources across the continuum of human service needs by soliciting proposals from nonprofit agencies for services benefiting low- and moderate-income residents.
- HS-12. Support and actively coordinate with local, regional, and national efforts that address local human services needs to ensure local programs complement programs provided at the county, state and federal level.
- HS-14. Support agencies locating human services facilities in Bellevue and, where appropriate, encourage efficiencies through agency collocation and collaboration.

Fiscal Impact

This Ordinance accepts a grant from HUD and authorizes the expenditure of an estimated \$917,000 to implement the 2020 CDBG recommendations as submitted by the Bellevue Human Services Commission. Funding for these expenditures is provided by an estimated \$764,000 from HUD's 2020 CDBG Grant Program, and \$153,000 of anticipated 2020 home repair loan repayment income.
