Resolution ratifying and confirming Third Civil Emergency Order Imposing Curfew of June 2, 2020.

EXECUTIVE SUMMARY

The Mayor of the City of Bellevue signed the Third Civil Emergency Order Imposing Curfew of June 2, 2020 imposing a curfew in a designated area in the City commencing at 5:00 pm on June 2, 2020 and continuing until 5:00 am June 3, 2020. Per Bellevue City Code (BCC) 9.22.020, the Order must be presented to the City Council for ratification and confirmation. If not so ratified and confirmed, the Order shall be void.

RECOMMENDATION

Move to adopt Resolution No. 9763.

BACKGROUND/ANALYSIS

The killing of George Floyd by a police officer in Minneapolis, Minnesota on May 25, 2020 has generated anger, outrage, protests, and demonstrations across the United States. In other cities, including Seattle, Portland, Atlanta, Phoenix, New York, Houston, San Jose, Los Angeles, Dallas, and Minneapolis, demonstrations over the killing of George Floyd have turned violent and led to other killings, property destruction, injuries to demonstrators and police officers, and use of force by police officers. Other cities, including Seattle, Portland, St. Paul, Louisville, Milwaukee, Columbus, Atlanta, Cincinnati, and Denver have declared states of civil emergency and established mandatory curfews. On the evening of May 31, 2020, looting and property damage, assaults on police officers, and other acts of violence occurred in the City of Bellevue, as well as refusals to obey dispersal orders.

On May 31, 2020, the Mayor, pursuant to the authority granted by BCC 9.22.010, determined that extraordinary measures were required to protect the public health, safety and welfare of the City's residents and therefore proclaimed that a civil emergency exists within the City of Bellevue. BCC 9.22.020.A authorizes the Mayor, during the existence of such proclaimed emergency, to make and proclaim an order imposing a curfew. In the exercise of such authority, on May 31, 2020, the Mayor issued a general curfew in the downtown area of Bellevue specifically described in Civil Emergency Order Imposing Curfew. On June 1, 2020, the Mayor issued a Second Civil Emergency Order Imposing Curfew in the same designated downtown area, commencing at 5:00 pm on June 1, 2020 and continuing until 5:00 am June 2, 2020. On June 2, 2020, the Bellevue Police Department continued to have reason to believe additional violent protests were likely to occur within the City the evening of June 2. Therefore, on June 2, the Mayor issued a Third Civil Emergency Order Imposing Curfew in the same designated downtown area, commencing at 5:00 pm on June 2, 2020, and continuing until 5:00 am on June 3, 2020.

BCC 9.22.020 requires that the Third Civil Emergency Order Imposing Curfew be presented to the City Council for ratification and confirmation at the earliest practical time. If the Order is not so ratified and confirmed, it shall be void.

This Resolution, if adopted, would ratify and confirm the Third Civil Emergency Order Imposing Curfew of June 2, 2020.

POLICY & FISCAL IMPACTS

Policy Impact

The Third Civil Emergency Order Imposing Curfew of June 2, 2020 was issued for the purpose of protecting life and property.

Fiscal Impact

There is no fiscal impact.
