EXECUTIVE SUMMARY

This Resolution will supplement the existing contract with HNTB Corporation for structural design engineering and construction support services for the Mountains to Sound Greenway Trail Project.

RECOMMENDATION

Move to adopt Resolution No. 9842

BACKGROUND/ANALYSIS

Design on the Mountains to Sound Greenway Trail Project between I-405 and 150th Avenue SE began in 2013. As the design progressed and construction funding was identified, the original design was broken into three phases to match available funding. The first phase is located between I-405 and 132nd Avenue SE which is currently under construction. The second phase is from 132nd Avenue SE to 142nd Place SE which is currently being advertised for construction. The third phase is from 142nd Place SE to 150th Avenue SE which is currently at 90 percent design.

HNTB Corporation was originally selected to complete design engineering and structural analysis work for the Soldier Pile Walls on the Mountains to Sound Greenway Trail Project between Factoria Boulevard and 150th Avenue SE as one complete project. To date, HNTB has completed structural design services and construction support services for Phase 1, completed design on Phase 2 and completed 90 percent on Phase 3. This supplement will provide for the completion of the design of Phase 3 and for construction support services for Phase 2 and Phase 3. The phasing of the work and elongated schedule has resulted in the need for this supplement.

POLICY & FISCAL IMPACTS

Policy Impact

Comprehensive Plan

The overall Mountains to Sound Greenway Trail Project is specifically listed in the Comprehensive Plan's Comprehensive Transportation Project List (CPTL No. 61). The project is also listed specifically within the 2009 City of Bellevue Pedestrian and Bicycle Transportation Plan (Project No. O-137-N). The

project and the actions proposed in this memorandum will advance multiple Comprehensive Plan Policies, including:

- TR-20 directs that the City, "Scope, plan, design, implement, operate, and maintain the
 multimodal transportation system in a corridor approach within and across Mobility Management
 Areas."
- TR-40 directs that the City, "Work actively and cooperatively with other Eastside jurisdictions and regional and state agencies to plan, design, fund and construct regional transportation projects that support the City's Comprehensive Plan."
- TR-45 directs that the City, "Develop and implement inter-local agreements for cooperative solutions for mutual land use and transportation concerns."
- TR-68 directs that the City, "Integrate pedestrian and bicycle access to transit as a means to serve neighborhoods."
- TR-105 directs that the City, "Implement the Pedestrian and Bicycle Transportation Plan and prioritize projects that:
 - 1. Address safety issues;
 - 2. Provide access to activity centers;
 - 3. Provide access to the transit and school bus systems;
 - 4. Complete and connect planned pedestrian or bicycle facilities;
 - 5. Develop primary north-south and east-west bicycle routes through the City;
 - 6. Improve multimodal level of service along travel corridors; and
 - 7. Serve residents who have special accessibility needs."
- TR-124 directs that the City, "Support including facilities for pedestrians and bicycles when planning, designing and constructing enhancements to I-90, I-405 and SR-520."

Fiscal Impact

This is one of three actions tonight related to the Mountains to Sound Greenway (MTSG) Trail. The other two actions include 1) Ordinance to increase the project budget for the MTSG Trail – 132nd Avenue SE to 142nd Place SE (CIP Plan No. PW-W/B-84) by \$5,930,000 and to award Bid No. 20007 to construct this project and 2) Resolution to increase the contract with KPG, PS for structural design engineering and construction support services.

This action obligates the City to an increase to the contract with HNTB Corporation in the amount of \$159,581.32, plus all applicable taxes, for structural design engineering and construction support services for the remaining section of the Mountains to Sound Greenway Trail between between Factoria Boulevard SE and 150th Avenue SE.
