

CITY OF BELLEVUE, WASHINGTON

RESOLUTION NO. 9880

A RESOLUTION ratifying the Emergency Declaration of the City Manager for the emergency repair or replacement of the Vasa Creek culvert, located near 15321 SE Newport Way, Bellevue, WA 98006; and ratifying an emergency contract with Sunbelt Rentals Inc., in the amount of \$160,000, plus all applicable taxes, executed pursuant to the Emergency Declaration.

WHEREAS, a public health and safety hazard, and threat to city infrastructure, exists near 15321 SE Newport Way, Bellevue, WA 98006; and

WHEREAS, this hazard and threat is caused by voids and anomalies of significance between the road's subgrade and the metal corrugated pipe culvert conveying Vasa Creek; and

WHEREAS, the pipe has significantly degraded with the passage of time, allowing water to escape the culvert and infiltrate the subgrade soils; and

WHEREAS, if the culvert is not immediately repaired or replaced, then there is a real and imminent risk of road instability and/or failure due to the water infiltrating the soil below the roadway; and

WHEREAS, an emergency culvert repair or replacement project is required to be developed and implemented expeditiously to protect the public's health, safety, and welfare; to protect surrounding property and the environment; and to protect the City's infrastructure; and

WHEREAS, on December 4, 2020, the City Manager declared a state of emergency to facilitate the City's response to the pending hazard and threat; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES
RESOLVE AS FOLLOWS:

Section 1. The City Council hereby ratifies the Emergency Declaration signed by the City Manager on December 4, 2020, for the emergency repair or replacement of the Vasa Creek culvert, located near 15321 SE Newport Way, Bellevue, WA 98006, which has been significantly degraded, is creating a public health and safety hazard, and is threatening city infrastructure. A copy of the Emergency Declaration signed by the City Manager on December 4, 2020, has been given Clerk's Receiving No. _____.

Section 2. The City Council hereby ratifies the emergency contract (date January 15, 2021) with Sunbelt Rentals Inc., in the amount of \$160,000, plus all applicable taxes, for bypass pumping of Vasa Creek, which was executed pursuant to the Emergency Declaration signed by the City Manager on December 4, 2020. A copy of the emergency contract (date January 15, 2021) has been given Clerk's Receiving No. _____.
