### **EXECUTIVE SUMMARY**

Due to a vacancy in the Assistant City Manager role in 2021, the City Manager's Office is seeking assistance in supporting the culture and performance of the City while the position remains vacant. To meet this objective, All Angles Consulting is being proposed to provide contracted support to the City of Bellevue, generally in the areas of process improvement and innovation initiatives.

### RECOMMENDATION

Move to adopt Resolution No. 9889

### **BACKGROUND/ANALYSIS**

The City has a number of critical initiatives underway to respond to increasing demand for highly coordinated and efficient service delivery. In some cases, we rely on staff who do not have specialized training or expertise to lead these efforts. For significant, key initiatives, such an approach does not make sense, but leads to rework, slower work or missed opportunities. Having this consultant dedicated to supporting staff and providing key expertise in our skill gaps until a permanent Assistant City Manager is on board will mean we do not lose critical time. All Angles Consulting has been engaged in Operations Policy Team facilitation and LEAN process coaching, which allows for insight into City culture, personnel, and needs that is uniquely suited to back-filling for the Assistant City Manager, who had general oversight of these initiatives and has now left the City.

### **POLICY & FISCAL IMPACTS**

## **Policy Impact**

Bellevue City Code 4.28 provides for the fair and equitable treatment of all persons involved in the purchasing process. Council approval is required to award the bid where the cost exceeds \$90,000.

## **Fiscal Impact**

Under existing City policy, the duration of this contract could be up to four years, however, we anticipate that the majority of services will be used in 2021, and the maximum contract amount is based on that assumption. The contract amount is set at a maximum of \$126,000, plus all applicable taxes. The contract allows the City to scale services as needed to meet demand and to modify our use of these services when the Assistant City Manager position is filled. This contract is fully funded in the General Fund, utilizing staff salary savings and other budgeted resources to pursue these kinds of initiatives.

# **OPTIONS**
