EXECUTIVE SUMMARY

This Resolution authorizes the execution of a two-year lease agreement, with three one-year renewal options, with Deli D's LLC DBA Copper Kettle Coffee Bar, to operate a coffee cart at Bellevue Botanical Garden.

RECOMMENDATION

Move to adopt Resolution No. 9926

BACKGROUND/ANALYSIS

The Bellevue Botanical Garden has offered year-round coffee cart service since 2016. The coffee cart sells espresso drinks, pastries, and other refreshments. This has proven to be a popular amenity for guests to the Botanical Garden. The coffee cart operates daily out of the Shorts House from January through November and operates nightly out of the Aaron Education Center during Garden d'Lights.

Consistent with City contracting policy, staff issued a request for proposals (RFP) in March to solicit competitive offers to operate the coffee cart. Deli D's LLC DBA Copper Kettle Coffee Bar was the only qualified applicant to respond to the RFP. This vendor has operated the coffee cart at the Bellevue Botanical Garden since 2018, when the current owner purchased the Copper Kettle Coffee Bar business from the original owner. The proposed lease agreement with Deli D's LLC will be for an initial term of two years with three options to extend for successive additional terms of one year each.

POLICY & FISCAL IMPACTS

Policy Impact

Bellevue City Code 4.30.020 requires Council approval to execute leases of real property where the term of the lease exceeds two years, consideration exceeds \$90,000 per year, or where City property is leased for less than fair market value.

Fiscal Impact

Approving this action will result in Deli D's LLC paying the City monthly rent plus leasehold excise tax, as illustrated by the table below, to operate its business at the Bellevue Botanical Garden.
