EXECUTIVE SUMMARY

This Resolution authorizes execution of a contract with Landscape Structures, Inc., for the demolition of existing play equipment and the purchase and installation of new play equipment at Chism Beach Park.

RECOMMENDATION

Move to adopt Resolution No. 9935

BACKGROUND/ANALYSIS

The current play equipment at Chism Beach Park was installed in June 2002. It has reached the end of its useful life. Staff selected the proposed new play equipment after working with the design team through several different designs based on a beach theme. Accessible components of the play equipment include five ground level accessible elements and four raised components accessible by transfer platform entry points.

The purchase will utilize a cooperative purchasing agreement with Sourcewell that allows the City to secure very competitive pricing.

POLICY & FISCAL IMPACTS**Policy Impact**

The Parks, Recreation and Open Space element of the Bellevue Comprehensive Plan supports the purchase and installation of the new equipment.

PA-34. Evaluate existing parks and facilities, renovate, where appropriate, to maximize efficient maintenance and operation practices, improve safety and accessibility for all user, and to reduce, where feasible, the impacts on adjacent properties.

Bellevue City Code Chapter 4.28 provides for the fair and equitable treatment of all persons involved in the purchasing process. Council approval is required to execute contracts that exceed \$90,000.

Fiscal Impact

This action will obligate the City to an amount not to exceed \$96,583.80 plus all applicable taxes. This project is funded in the 2021-2027 General Capital Investment Program (CIP) through CIP Plan No. P-R-11, Renovation and Refurbishment of Park Facilities.

OPTIONS

1. Adopt the Resolution authorizing execution of a contract with Landscape Structures, Inc., in an amount not to exceed \$96,583.80, plus all applicable taxes, for the demolition of existing play equipment and the purchase and installation of new play equipment at Chism Beach Park.
2. Do not adopt the Resolution and provide alternative direction to staff.
