The residents are very well to do. Average income is high. Older residents that begin to retire might find Bellevue unaffordable.

Financial insecurity may be a concern. Are people in this community talking to each other? Are they listening to each other?

Bellevue is a healthy community with good prosperity.

Aging-in-place would say need to pay attention to accessibility.

As to sidewalks and paths, the map showed 108th as sidewalk. However. 1/2 of 108th has the road extension (with a white line) designated as for walking and part of that walking area are city drainage...not good walking

Most traffic concentrated on certain streets. So many areas restrict thru traffic. We are a car centered city.

More BPD traffic enforcement on Bellevue Way, especially north of 112th NE.

The Park is a source of traffic problems. Still we shouldn't get rid of it. It should be patrolled more often

Very diverse population with a very high average income. However seems that one third of the population is cost burdened. This would lead to very different needs- challenging for the city to balance these.

Affordability is an issue.

Create park walking groups

More instruction on recycling and support for special materials (e.g. Styrofoam). It's difficult when the recycling instructions change - e.g. no more shredded paper in the organics

How can we support people who move here from other places without good recycling systems

More pocket parks - provide access for everyone - you don't have to go very far. Neighbors meet each other and get to know one another.

Education on trees - explain how to maintain trees without having them fall - alleviate concerns. If trees aren't maintained, they can get unhealthy - contribute less to society benefits and can get dangerous.

Garden at all the schools - use for education for kids in particular

Label trees in parks for education. Like Botanical Gardens on neighborhood scale.

More dog potty spaces. - Lots of the multi-family areas don't have spaces other than private yards for dogs to do their business. Bad for plants

Pathways with hard surfaces, reduce sharp elevation changes - shallower, longer pathways where possible

Place more benches along pathways, useful to take a break, particularly if there are mobility issues.

Dwarf crabapples along 12 were mostly removed - they were a unique plant with a good scale along the sidewalk. Incentivize solar on new homes - particularly for builders.

Strict rules – requirements about planting trees, requirements to replace trees, rules about not removing trees

• There should be big fees for cutting down trees without a permit. This should be tracked better so that projects ignoring the rules aren't missed.

- The fee should be big enough that developers/builders don't ignore it just to get a project constructed.
- Hire a full-time arborist for the City to oversee trees across the city. A tree insurance type program would save money over time by helping mitigate risk and keep the city from losing trees in some instances.
- Utilities and other public works aren't pruning properly but instead hacking off branches abruptly, damaging both the trees and the visual impact of the trees
 - Provide financial assistance to help hire arborist for low income families. Would benefit public.
- There should be clear values attributed to types, sizes, ages, quality of different trees. This helps with understanding the value before cutting them down
- Most people don't realize the difference in environmental impact can the City highlight a demonstration project showing the benefits of a small house designed with best practices over a large house maximizing the lot?
 - 5-6000 SF homes are a concern from a sustainability perspective

Access to EastRail trail at multiple points

- Lots of agreement on this one people miss the small pocket parks that used to exist Downtown and would like to see these in the neighborhoods
- Many people can't go far from their homes but just want a place to sit and rest (accessibility concerns) and meet neighbors for a chat (getting to know one another)
- Suggestion to have City watch for small lots available in the neighborhoods for purchase and transition into small pocket parks scattered throughout so that everyone has access to a park within a short walk

More sidewalks to provide access to parks etc.

- Flyers highlighting tree locations, benefits, and ways to mitigate disagreements and solve problems (see next bullet)
- Education around maintenance
- Not everything has to be a rule sometimes education is enough
- Lots of disagreements between neighbors about trees let them know about the Conflict Resolution Center

- Trees should be part of the design review process for all projects there need to be reasonable reasons for cutting down trees. Clearcutting a site should not be the default option.

Adopt-a-tree program - this would help provide a sense of neighborhood ownership and also help provide education opportunities.

Company with money, like Forterra, could partner with non-profits to scatter pockets of green space throughout the City

What would it take for you to fully support these sense of place goals and policies?

The neighborhood has little character & is being over run by oversized overpriced McMansions & dragged down by crumbling old houses that aren't being maintained Your policies don't address either of these issues

I would LOVE to see the city encourage people to better maintain their homes/yards (POLICY S-NW-3) but I do wonder how effective this will be.

Move traffic off of residential and minor streets such as main and 100 NE

Encourage use of 4th and 8th

To better understand HOW each of these goals and policies can/will be achieved. Right now they read as "aspirational", but I don't see how my neighborhood will benefit.

Make safe walkabilty a priority. Maintain grafitti free look. No tents, shopping carts full of stuff. Have a plan to keep it in check.

Need more specifics. We live in Vuecrest and do feel the crush of the oncoming high buildings and traffic.

My concern is about the scale of development in my neighborhood. Five million dollar mega-mansions are becoming the norm in a neighborhood of original Bell and Valdez homes. The result is skyrocketing property taxes and setback to setback homes that are in the neighborhood of 6,000 square feet. It is not comfortable to live next door to a home that towers to a height of three stories and "peers" into your yard.

There's no safe routes for bicycles across NW Bellevue north-south. Directing vehicles to arterials is great but the only street out of the north end is a dangerous highway.

Stronger landscape buffers and green areas

"Preserve" and "maintain" the "existing character" reads to me like NIMBY-ism. I want our neighborhood to embrace change, be vibrant, and be welcoming.

Change direct vehicles away from residential streets to prevent commuters from turning residential streets into rush hour arterials.

no cottage homes

clarification of the goals

Keeping sub neighborhood character and existing housing stock would have been nice goal 15 years ago, no longer possible.

I would need to be better informed and understand the respective pros and cons of each policy.

NW should seamlessly integrate into downtown. Density should build as one approaches downtown rather than a hard border.

What would it take for you to fully support these sense of place goals and policies?

Not sure why I am being asked about NW Bellevue only. Is Meydenbauer Bay NW Bellevue. I don't understand some the policies, e.g., "Peserve the existing sub-neighborhood characters by encouraging rehabilitation and maintenance of the existing housing stock." What does that mean? What are "experimental qualities"?

That you add the need to slow traffic down, especially where kids and parents gather for school buses, and that you add more places where people can safely cross the streets.

The only one I disagree with is POLICY S-NW-3. Although there are challenges with redevelopment (like loss of our older trees in many cases), I view recent high-volume replacement of existing housing stock as a positive. Many (not all) of the older dwellings in my neighborhood have been poorly maintained and their removal is a positive for the neighborhood. In addition, as smaller older homes have been replaced with larger modern homes, this has a) made the neighborhood more attractive to families with young kids, b) better utilized the land in our neighborhood, and c) increased property values and tax revenue for the city. I would NOT want the City of Bellevue to obstruct what I consider progress.

for seniors to "remain" in the neighborhood as they age, they need to be able to stay in their homes. They don't want to move to "new" senior living spaces. Taxes are driving many out.

I don't like the idea of tiny houses or units in people's back yard. I love our natural park with the trail North of Devonshire on Bellevue Way.

Not sure what is meant by bringing people together. We seem to have a wonderfully diverse population and it is enjoying strong growth.

Maybe add some detail to POLICY S-NW-11. It seems more vague than the others, and I don't know what it means.

This is liberal speak for spending money on needless projects.

I support seniors staying in place and multi-generational families but not single family houses rented by un-related people.

Parks and the like are already open to all, don't spend money to change

These goals seem more important than the first set of goals to the ongoing vitality of the neighborhood. Neighbors need to connect!

improving lower income housing in downtown believue and northwest believue for those that qualify.

There is nothing in this that address the high property tax. we need to get smart about how we use our tax dollars and the State keeps adding taxes which will continue to price out diversity in West Bellevue

clarification of the efforts and goals

This is aspirational but I do not think some of these are realistic

More information. Understand the pros & cons.

These all seem very vague. Are we talking about creating senior centers and more community centers? Would they be in the neighborhoods themselves or in the DT area? Are these going to be things that people can walk to? Are we talking about more parks? I like parks but we should look at what parks are most heavily used and for what purposes.

I would Bellevue to have a plan on how to prevent camping and transient camps being built in any parks.

What would be needed for you to fully support these sense of community goals and policies?

Admittedly, I've only lived in my neighborhood for eleven years, but to suggest there is a history of neighborhood cohesion or even coherent subneighborhoods seems like wishful and inaccurate. For instance, investing in the "Northtowne" sign at Bellevue Way and NE 17th was a silly boondoggle as only a handful of residents even consider Northtowne a thing.

I'm somewhat skeptical of city initiatives to foster neighborhood cohesion, outside of providing public spaces for people to gather.

I'm not fully convinced about S-NW-19 - I think that is more likely to create issues with loiterers as it is to provide a benefit to me and my neighbors.

I like S-NW-20 to 22 a lot.

I am not sure the city needs to spend resources on this

encourage mixing smaller lots and/or smaller houses/housing into neighborhoods, which would allow seniors to "age in place" in more affordable resident-owned houses. (also encourages more affordable housing mix in neighborhoods)

Follow through

Stop doubling property tax - no one can afford to stay

On the write up of the "sense of community." Am repelled by the wording of the first line in the second paragraph. I think it expresses a personal statement not a community statement. I would prefer, "residents desire ways to learn about their neighbors"

Under Policy NW-15, or separately, want to encourage more cooperation between the city and BSD for shared use of spaces.

NW-18 - am concerned about the terms "users with a variety of physical abilities" would prefer "for handicapped accessible facilities."

NW-19 instead of "rest" use "interact and engage with each other"

What would be needed for you to fully support these housing affordability goals and policies?

How does house sharing help anyone except money grabbing landlords? How does accessory dwellings help? Build affordable housing

I question whether backyard dwellings are such a good idea.

Please don't encourage this. The reason I bought a home where I did is because the area was safe and free from the crime that tends to follow these low income housing units. The things that you're trying to do here discourage me from walking around my neighborhood with my kids, hurt my home's value, worry about not chaining my grill to a pole, etc. There has been a noticeable uptick in crime (assaults, smash & grabs, etc.) after the low-income apartments went in behind St. Lukes. Please stop. There are plenty of low income housing options in Renton.

I don't agree with ADUs in my neighborhood. Not enough sidewalks - actually none. increased housing in my neighborhood puts more vehicles on the roads, which are not designed for multifamily living. Lots of people walk, with pets, children, and families. Several us walking assisted devices. My neighborhood should remain designated for only single family homes.

No, I don't care for backyard/mother-in-law dwellings. This is a slippery slope and not why we like living here.

Again, I get back to the issue of taxes and livability - the two are intertwined. So-called mother-in-law apartments are something I can live with. In fact, my views about these have become more favorable over the recent years.

Is there any way to slow (or stop) the tearing down of smaller, older houses and the building of multi-million-dollars McMansions on their lots? I see way too much of this going on.

discourage house sharing

NW Bellevue barely has any character remaining. It's all generic mega mansions with three car garages. We're doing the same to West Bellevue now. We don't want to become Seattle.

I disagree with Policy S-NW-25 -- this is total NIMBY-ism. We should embrace accessory dwelling units and specifically tiny homes. Tiny homes should be allowed per residential zoning laws. They should be able to be visible from the street and should become apart of our character. Housing costs are so extreme here, and allowing a legal way for these homes to exist would make Bellevue more affordable for so many people and would normalize other housing options. Single-family homes are not the only American dream.

let free market sort it out

I think there should be a greater push for lower income housing in downtown bellevue and northwest bellevue. stop allowing these massive useless houses that make little to no sense in the community.

the above proposal should not affect my area of residency

What would be needed for you to fully support these housing affordability goals and policies?

Don't subdivide residential properties or rezone residential areas

This is especially important where there are public transit options and walkability to employment centers.

I feel this would decrease our property values

I need to know more about POLICY S-NW-25 before I know whether I support POLICY S-NW-24. From my own personal experience with neighbors making unpermitted additions on their property, I start off skeptical that the regulations *and* enforcement will be sufficient.

in addition to ADUs, would like to see encouragement of small(er) resident-owned (not just renter) houses available within neighborhoods (s-nw-23?). [currently, all new development appears to maintain lot size with larger and larger houses, reducing any affordability]

I also think it is important to restrict the size of new homes built on lots in NW Bellevue. Many smaller older homes in good condition are being torn down and replaced with McMansions, which has changed the neighborhood significantly.

What would be needed for you to fully support all of these mobility and access goals and policies?

More focus on safety for cyclists & pedestrians Better transit systems

We need to slow down traffic on Bellevue Way, install more crosswalks where school buses stop.

Local residents should be able to use neighborhood streets to bypass arterials. Arterials are often clogged.

This is a good start, but this needs more thought. You first need to realize that public transportation is useless for most of us (unless I'm trying to get from downtown believue to Microsoft). Personally, I would end up walking about 3 miles plus adding almost an hour to my car commute to work (NW Bellevue to Redmond). That's not practical and it won't ever be. I'd much rather see improvements to onramps and roads than wasted on public transportation. Speeding has been a growing problem in the area over the last few years. How about put some speed traps along Bellevue Way and arterial streets? Police presence has been early nonexistent and many of these roads have gotten dangerous to walk along over the last few years. Please don't add speed bumps...my car bottoms out on some of them in Bellevue so I need to be careful about which routes I drive.

Blind corners are another problem that drastically needs to be addressed. This is mostly due to unmaintained landscaping (mostly ivy, blackberries, or overgrown trees). This is an EASY fix that I believe would have the biggest impact on your goals here.

Slow down and discourage traffic on 100 th NE and main. Especially by park, boys and girls club and Rotary play area Speeding, night racing and commuter traffic will cause accidents

again, HOW will these be achieved? Support, encourage, explore are passive attempts and really mean nothing. What will get funded? How?

There needs to be a safer way to cross Bellevue way by bike at the north side of the 520 overpass. There is no easy way up onto that big sidewalk. It feels unsafe. Love the bike lane on 112th! Would love a better sidewalk buffer of landscape all the way on Bellevue Way. 520 to Downtown always feels 1/2 finished.

Add some speed bumps in the Vuecrest neighborhood

There are two traffic issues that alarm me here in Bellevue. The first is right turning traffic ignoring pedestrians trying to cross in front of them. Perhaps a "walk" sign could flash "on" prior to traffic getting the green "go" light. Bellevue drivers are not particularly considerate of pedestrian traffic.

My second issue is one that, perhaps, the city of Bellevue cannot solve. It is the intersection of the Hwy. 520 off ramp as it exits on to Bellevue way. The jersey barrier is so high that southbound traffic on Bellevue Way cannot see a motorist running a red light until it is too late. I have been a witness to one "T-Bone" accident and one fortuitous near miss. If Bellevue drivers weren't so cavalier about running red lights, I would not be so concerned.

What would be needed for you to fully support all of these mobility and access goals and policies?

I don't see anything about speed on Bellevue Way. How long has it been since someone was killed in one of the few crosswalks there? NW Bellevue is a dangerous place to walk when you need to actually go somewhere.

More walking trails within Bellevue.

Bike, pedestrian, metro/bus priority and support is key

Improve pedestrian safety and decrease traffic but increase density with ADUs and household sharing. These goals conflict. do not over sell light rail

create sidewalks. add more speed bumps or traffic lights - especially in north west believue so the fuck tard loud speeding race cars cant speed anymore. Believue needs to move to a more carbon neutral less car traffic more pedestrian and bicycle friendly lifestyle. with the move of amazon, google, microsoft and facebook to downtown believue there is only going to be a mass increase in traffic and cars should not be the way to go so creating an environment that is better for pedestrian and bicycle traffic would alleviate that.

I live close to downtown Bellevue and wall all over my neighborhood and the downtown area. I think its pretty good but we can improve sidewalks in some neighborhoods with larger arterial streets and more speed bumps to keep the speeding down

Policy 37 and 39 are not clear

Pedestrian priority should also happen in DT. Bellevue Way should be pedestrian only from 4th-8th opening it to a promenade. It is dangerous and dumb to have so much traffic in the heart of shops and restaurants. Traffic should be rerouted to 106th.

Again not sure why I am asked to focus on NW Bellevue. I do ride a bike and walk from Meydenbauer 99th and Lake Wa into town. Traffic on Lak Wa is not safe for walkers, there are no bike lanes as you approach Main st. and additional crossings need to be added for residents.

There are school bus stops all along Bellevue Way North now and parents and kids need more places to safely cross. The blocks are now too long and there are not enough crosswalks by the busstops. This should be fixed before there is a horrible accident.

sidewalks both sides of 100th homes along 100th should maintain their landscape as to not block the sidewalks and not to block views of oncoming traffic at corners

I don't understand exactly what POLICY S-NW-37 has in mind. In general, I think I might support it, but it depends on generally where and what is envisioned by it. As is, it is too vague for me to support.

I have been an advocate for increasing the number of pedestrian crossings on Bellevue Way, especially at North Towne shopping center and possibly at another location somewhere between 1st Pres Church and NE 24th, to encourage more pedestrian access. I love the idea of increasing the number of gathering places and putting benches along streets, especially for older residents in our hilly neighborhood, to encourage walking.

Enact traffic calming on arterials and have a standard speed of 25 MPH in the city that is enforced.

The write up is good, simple and straightforward.

On NW-28: add "consider traffic calming devices"

On NW-37: this has to do with land-use and would like to add "allow 20-25% expansion of Northtown Shopping Center."

On NW-38: Add in "prioritize multi-modal transportation enhancements"

What would be needed for you to fully support these environment goals and policies?

Trees need to be maintained to prevent damage from windstorms. Green spaces cannot become campsites for street people.

Lots are being clear cut to make room for the homes and then given "cookie cutter" landscaping with all the usual ordinary plantings and almost NO bigger trees. I doubt there are many homes that have more tree canopy than mine as the failure to get much sunlight on my garden will testify.

It's dangerous already and will become more so when 30k more daytime employees are waking the streets at lunch time. Time to ditch planning around the automobile. As a downtown resident/homeowner, I am happy to reroute my drive to avoid those areas.

Often the plan groups bicyclists and pedestrians together, but I think that is an oversimplification for our neighborhood. From my experience in NW Bellevue, we have more pedestrians than bicyclists, even though the pedestrian infrastructure here is often severely lacking (108th Ave NE doesn't even have sidewalks between NE 20th and 24th Sts.). It seems like a lot of thought and money goes toward bicycling improvements, but much less thought goes into making our neighborhood more safely walkable. Yes, our neighborhood does have some avid cyclists, but every day you can see people from 3 to 93 walking out streets. I'd like to see more thoughtful pedestrian-first planning instead of more bike lanes (which many kids don't use anyway, since they're often restricted by parents to riding on sidewalks).
