





THE VISION

"NORTHEAST BELLEVUE IS A COMMUNITY OF CARING AND CONNECTED NEIGHBORS."

This is what Northeast Bellevue residents aspire for their community as they move into the future. They see it as a quiet retreat from surrounding activities, lined with trees and protected from the hustle and bustle of urban life but still within reach of those amenities. They envision a safe community where neighbors listen to each other, raise issues, and collaborate on shared values. Maintain woodsy feel and buffers from activity

- S-NE-3: "Encourage a graceful transition between the neighborhood scale of Northeast Bellevue and the scale of higher intensity uses in surrounding neighborhoods."
- S-NE-5: "Maintain a treelined buffer along Bel-Red Road to buffer adjacent homes from adverse impacts."








Sense of Place: Boundaries


- S-NE-6: "Multifamily development is not allowed within Northeast Bellevue District A. Existing multifamily uses within District A can be converted to senior citizen housing, senior congregate care housing, assisted living and nursing homes."
- S-NE-7: "Retail uses are not allowed north of NE 24th St within Northeast Bellevue District A."
- Addition: "Office use is appropriate for the property east of 156th Avenue NE between Northup Way and NE 24th Street."

City of Bellevue





- Enhance gathering opportunities
- S-NE-12: "Create new gathering places for community members to meet, mingle, and get to know one another."
- Community programming and education
- SE-NE-14. Build neighborhood connections by celebrating the diverse cultural backgrounds of Northeast Bellevue's residents and supporting community events and avenues of communication.





Housing Affordability

- S-NE-18: "Explore introducing a mix of new housing typologies such as detached accessory dwelling units, duplexes and triplexes to allow options for a range of households."
- Policies providing a framework for new typologies:
 - S-NE-19: "...maintain adequate separation from adjacent properties..."
 - S-NE-20: "Ensure adequate infrastructure exists..."
 - S-NE-21: "Minimize impacts... to the environment and to the existing residential character..."
- Aging in place support for seniors







- Safety for all modes of travel
- "Expanding transportation choices"
- S-NE-31: "Support increased public transportation service including first and last-mile ondemand transit services and connections to and from light rail stations, major transit centers and other key destinations."
- Access to goods and services







- Support Citywide tree preservation code assessment. Encourage tree planting and education

THE VISION

"NORTHWEST BELLEVUE IS A COMMUNITY WITH DIVERSE OPPORTUNITIES FOR EVERYONE."

This is what Northwest Bellevue community members envision for their neighborhood area as they move into the future. They see it as a welcoming one, with a diverse range of residents living and working within. It is both active and quiet, a destination and a home, connected to yet set apart from Downtown. Throughout both its denser multi-family or commercial areas and the calamer singlefamily streets. Northwest Bellevue will have maintained a neighborhood feel and embraced the natural beauty and green character of the Pacific Northwest. This balance defines the unique variety that is found in the area, a variety that is preserved in order to allow for diversity – of residents, of experience, and of opportunities.

- Maintain variety of sub-neighborhoods
- S-NW-7: "Explore opportunities for small-scale commercial uses at key locations to improve access to goods and services throughout Northwest Bellevue."
- Coordinate with local jurisdictions
- S-NW-9: Encourage "buffers such as McCormick Park and/or gradients of building scale" to "ease the transition" to Downtown Bellevue.











- Encourage ways to "welcome new residents" (S-NW-17)
- Focus on inclusivity for all
- Aging in place: support for seniors
 - Example S-NW-23: "Encourage housing for the elderly in areas designated for multifamily development."



Housing Affordability

- S-NW-24: "Encourage a mix of housing typologies, within both lower and higher intensity districts, to allow for a range of affordability options, size of housing units, ease of movement for the physically disabled, and visual styles."
- Explore introducing DADUs and work towards limiting their impact on "the residential character of the street."







- Focus on pedestrian safety
- Support additional modes of access (bicycling and transit)
- Vehicular movement safety and efficiency
- S-NW-39: Prioritize access to particular areas such as "between residential areas and popular destinations, particularly schools and parks."








