EXECUTIVE SUMMARY

This Resolution authorizes execution of a contract for the demolition of existing play equipment, purchase, and installation of new play equipment at Northtown Park.

RECOMMENDATION

Move to adopt Resolution No. 9970.

BACKGROUND/ANALYSIS

The current play equipment at Northtown Park was purchased and installed in 2002, and has reached its end of life. Staff selected the proposed new play equipment after collaborating with the Gametime, Inc. design team; working through several different designs based on inclusive play that fits in the existing playground area and posting signage of proposed design for the community to provide input. The new play structures will be accessible for children ages 2-12, including transition platforms and ground base play, as well as a tandem swing accessible for an adult accompanying a child at the same time.

The purchase will utilize the Omnia Purchasing program of which the City of Bellevue is a member that allows the City to secure competitive pricing.

POLICY & FISCAL IMPACTS**Policy Impact**

The Parks, Recreation and Open Space element of the Bellevue Comprehensive Plan supports the purchase and installation of the new equipment.

PA-34. Evaluate existing parks and facilities, renovate, where appropriate, to maximize efficient maintenance and operation practices, improve safety and accessibility for all user, and to reduce, where feasible, the impacts on adjacent properties.

Bellevue City Code 4.28 provides for the fair and equitable treatment of all persons involved in the purchasing process. Council approval is required to award the bid where the cost exceeds \$90,000.

Fiscal Impact

This action will obligate the City of an amount not to exceed \$110,949.09, plus all applicable taxes. This project is funded from the 2021-2027 General Capital Investment Program (CIP) through CIP Project No. P-R-11, Renovation and Refurbishment of Park Facilities, using partial funding provided by Amazon's community donation.

OPTIONS

1. Adopt the Resolution authorizing the execution of a contract with Gametime, Inc., for the demolition of existing play equipment and the purchase and installation of new play equipment at Northtown Park, in an amount not to exceed \$110,949.09, plus applicable taxes.
