

CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 6590

AN ORDINANCE relating to speed limits; amending Section 11.32.015 of the Bellevue City Code (BCC) to establish a speed limit of 20 miles per hour (mph) on streets comprising the East Bellevue Demonstration Greenway (Greenway) along the 165th/166th Avenues corridor between SE 14th Street and Northup Way.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. Section 11.32.015 of the Bellevue City Code is hereby amended to read as follows:

The speed limit on the following streets is 20 miles per hour:

SE 2nd Street from 108th Avenue SE to 109th Avenue SE.

SE 1st Street from 110th Avenue SE to 109th Avenue SE.

109th Ave SE from SE 1st Street to SE 11th Street.

SE 11th Street from 108th Avenue SE to 109th Avenue SE.

110th Ave SE from SE 109th Avenue SE to 111th Place SE.

SE 10th Place from 110th Avenue SE to 115 feet west of 110th Avenue SE.

SE 10th Street from 110th Avenue SE to 190 feet east of 110th Avenue SE.

111th Place SE from 110th Avenue SE to 150 feet north of SE 9th Street.

SE 9th Street from 111th Place SE to 110th Avenue SE.

SE 6th Street from 109th Avenue SE to 110th Avenue SE.

110th Avenue SE from SE 6th Street to SE 4th Street.

SE 4th Street from 109th Avenue SE to 350 feet east of 111th Avenue SE.

111th Avenue SE from 150 feet south of SE 4th Street to 250 feet north of SE 2nd Street.

SE 2nd Street from 110th Avenue SE to 111th Avenue SE.

110th Place SE from SE 4th Street to SE 2nd Street.

SE 3rd Street from 109th Avenue SE to 110th Avenue SE.

110th Avenue SE from SE 3rd Street to Main Street.

110th Place SE from Main Street to 350 feet south of Main Street.

165th Avenue NE from Northup Way to NE 12th Street.

165th Place NE from NE 12th Street to 933 166th Avenue NE.

166th Avenue NE from 933 166th Avenue NE to NE 4th Street.

165th Avenue NE from NE 4th Street to Main Street.

165th Avenue SE from Main Street to 157 Lake Hills Blvd.

Lake Hills Blvd from 157 Lake Hills Blvd to 165th Avenue SE.

165th Avenue SE from Lake Hills Blvd to SE 7th Street.

SE 7th Street from 165th Avenue SE to 166th Avenue SE.

166th Avenue SE from SE 7th Street to SE 14th Street.

Section 2. This Ordinance shall take effect and be in force thirty (30) days after its passage and legal publication.
