Thank you for your help planning a new 13.7-acre park in Newport Hills!

Construction of the new park located at 11560 SE 60th is expected to begin later this summer. The new park will combine approximately 10.7 acres of forested trails with 3 acres of developed park area that will include an open lawn, landscape, playground, loop trails, picnic shelter, restroom and fenced off-leash dog area.

Our initial park naming efforts did not yield a park name being selected so we are back to the drawing board. Once again we are asking for your help to name the new park. Although the park name will not be based on a vote, the Parks & Community Services Board and Bellevue City Council would appreciate hearing your input when they select a name for the new park. The City Council is expected to adopt a name this fall.


