# Scope of the KCRHA

The KCRHA was formed through a signed interlocal agreement (ILA) between Seattle and King County effectively merging the two agencies' homelessness response work into a new entity.

The KCRHA manages unified planning and coordination of funding and services for people experiencing homelessness countywide.

# Design & Inter-Local Agreement (ILA)

National Innovation Service engaged in 2018 to evaluate the system. KCRHA established December 2019 by ILA between Seattle and King County

# Administrative Start-Up & Global Pandemic

King County, Seattle, and Sound Cities set up governance structures for KCRHA; COVID-19 changed the landscape and responses to homelessness.

# Hiring & Planning

CEO Marc Dones started in April 2021, focused on start-up & hired executive team. Started sub-regional planning in late June; expect a snapshot report by September.

### **Contracts with Service Providers**

#### KCRHA assumes contracting from King County & Seattle:

- Over 200 contracts and ~\$140 million for 2022
- Terms stay the same through 2022 but are consolidated
- RFP and full-system re-bid for 2023
  - Potential for significant changes

## **Catalytic Portfolio**

In addition to the outlined work and responsibilities of the KCRHA, we are seeking additional funding from philanthropic partners to support a body of work we are calling the "catalytic portfolio" or three transformative changes to our current homelessness response system:

- Peer Navigation as Outreach
- By-Name List & High-Quality Data
- Bridge Housing
